Letter from the Director

This summer, the BID Initiative's initial grant period formally drew to a close. To mark the occasion, we're sharing our successes, challenges, and lessons in a new web feature.

The BID Story highlights the value of collaborative, country-driven planning, local leadership, and continuous learning and adaptation when developing and deploying new tools. Using a combination of personal perspectives from those involved in BID's design and implementation, an infographic, and a comprehensive account of BID's journey, it also illustrates why we are optimistic about the progress in Tanzania and Zambia, and future efforts to improve health outcomes by transforming data collection, quality, and use. We hope it will help other countries and immunization stakeholders learn from our challenges and experiences along the way.

Though the original BID Initiative grant has drawn to a close, the overall portfolio will continue as we work with the governments of Tanzania and Zambia to scale their electronic immunization registries (EIRs). We've also begun a new effort to support other countries interested in implementing similar data quality and use interventions through a mentorship model, continued activities with the BID Learning Network, including the launch of the BLN/Gavi Data Quality and Use Collaborative, and are leveraging the data captured through the EIRs to answer priority questions about Tanzania's and Zambia's national immunization programs. Stay tuned for more information about the BID portfolio work that will continue into 2019.
